


## Minutes of the April 12, 2021 Regular Meeting of Otto Township Board

1. Meeting called to order by Troy Salo at 7:08 PM. Persons present were Supervisors Troy Salo, Todd Lorentz; Clerk John Carlson, Treasurer Conrad Mack. Patrol Operator Eric Bakka, Cordell Huebsch, Joe Saenger, Elaine Bentley.
2. Gopher Bounty was paid to: No one.
3. Motion by Troy and second by Todd to approve *March* minutes and it passed.
4. Motion by Troy and second by ~~Derek~~ <sup>Todd</sup> to pay checks #7897 thru #7919 in amount of \$14,695.35 for all claims and payroll in the month of *April*.
5. \$158,887.31 the actual balance in checking account before the meeting  
\$0.00 the amount in CDs  
\$158,887.31 in total money  
\$14,695.35 Total spent this month.
6. Cordell Huebsch requested 470<sup>th</sup> Ave be graded immediately due to being in poor condition after the spring thaw. The board noted they will get to it soon and the plan was to provide dust control on this road again due to heavy traffic.
7. Joe Saenger requested dust control. He also requested the board install some additional gravel on Sandy Lane prior to its application so it holds up better. Board agreed.
8. Elaine Bentley requested the ditch on 510<sup>th</sup> Ave in sections 13/14 be cleaned out due to the road staying wet due to springs. Gravel also needs to be added. Board will review.
9. Todd motion and 2<sup>nd</sup> by Troy to elect Troy Salo as Chairman of the board.
10. Approve approach request with no culvert to Foley on 478<sup>th</sup> Ave and Weiland with a culvert on 490<sup>th</sup> Ave.
11. Seeing quite a bit of garbage dumped around the area of 490<sup>th</sup>/500<sup>th</sup> Ave & 360<sup>th</sup> St. area.
12. In need of additional Grader operators.
13. Reorganizational meeting was held. Troy Motion and 2<sup>nd</sup> by Todd to eliminate the \$400/month computer allowance for the clerk/treasurer and move that amount into their base salary as they now have Township owned computers to use. Clerk new base salary is now \$2,600. Treasurer new salary is now \$2,000. All else to remain the same. Motion passed.
14. Coronavirus Local Fiscal Recovery Fund will be approximately \$60,000 paid out over two years to Otto Township. Regulations on how it may be spent are forthcoming.
